The Board of Trustees of the Village of Stickney met in regular session on Tuesday, February 21, 2023, at 7:03 p.m. in the boardroom located at 6533 W. Pershing Road, Stickney, Illinois.

Upon the roll call, the following Trustees were present: Trustees White, Milenkovic, Torres, and Kapolnek Absent: Trustee Savopoulos and Hrejsa

Trustee Milenkovic moved, duly seconded by Trustee Kapolnek to approve the minutes of the regular board meeting held on Tuesday, February 7, 2023

Ayes: Trustees White, Milenkovic, Torres, and Kapolnek

Absent: Trustee Savopoulos and Hrejsa

Nays: None

Mayor Walik declared the motion carried.

Trustee White moved, duly seconded by Trustee Milenkovic that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.

Upon the roll call, the following Trustees voted:

Mayor Walik declared the motion carried.

Trustee Torres moved, duly seconded by Trustee Kapolnek to Request to hire one (1) Probationary Patrol Officer from the Lateral Police Officer Eligibility List.

Upon the roll call, the following Trustees voted:

Ayes: Trustees White, Milenkovic, Torres, and Kapolnek

Absent: Trustee Savopoulos and Hrejsa

Nays: None

Mayor Walik declared the motion carried.

Prior to the vote, Mayor Walik explained that we already have hired four officers already. One just left. It is happening everywhere. They come and go. As an example, Bedford Park is hiring police and firefighters with required specifications. He heard that Aurora is hiring people with a high school diploma. People are going anywhere the money is at.

MAYOR'S REPORT: He asked people to take care with the forecasted ice and snow.

CLERK'S REPORT: Information was provided on a proposal from the Illinois Department of Resources to submit legislation that amends the Level of Lake Michigan Act to collect an annual water allocation review fee of up to \$5,000 from all Lake Michigan Water Allocation permittees. The Illinois Municipal League is reviewing this matter and they are seeking opinions and questions to share with the IDNR a response to the proposal. All fees collected would be deposited into a specially designated portion of the Illinois Boat Fund to be solely utilized to assist communities in the Lake Michigan Program. In addition: The Clerk told the audience that the Harlem/Pershing TIF resolution will be on the March 7, 2023 agenda.

<u>Trustee Torres:</u> We were given information concerning filing with the Stickney Township Assessor at the North Clinic to challenge your property taxes. She reminded people of the free services that are available through the Township. The Trustee is working on upcoming programs. See the next newsletter for the events and dates. The Mayor interjected that the newsletter will be out in a couple of weeks.

Happy Birthday greetings were given to the Mayor.

DEPARTMENT REPORTS:

<u>Public Works Director Joe Lopez:</u> The street sweeper repairs and tune up have been made. They will start sweeping the alleys tomorrow. This sweeper is a 2010 Pelican.

<u>Police Chief James Sassetti:</u> The Chief brought our attention to our new metal detector in use in the lobby. It is a sign of the times. We are being proactive. It was purchased through funds obtained through a grant from the State of Illinois at no cost to the residents. It is on wheels so it is portable and can be used elsewhere. It's unsure when the newest officer will start.

<u>Fire Chief Jeff Boyajian:</u> A synopses was given by Fire Chief Jeff Boyajian of the 2022 Annual Fire Department Report.

As COVID restrictions were lessened earlier in the year, we were happy to be able to get back into our regular annual "routine" and complete important tasks that had been put on hold:

- The fire prevention bureau completed all fire safety inspections and ensured our commercial and industrial districts were operating safely.
- The Public Education team was able to get back into the schools and daycare centers to teach the children about fire safety. We were able to return to school with the Fire Safety Trailer (smoke trailer) allowing both Edison and Home Schools to practice exiting a building safely if it were on fire.
- We continue to support our seniors by joining them at their scheduled meetings. Providing them with information about the KNOX Box loan program and both verbal and written information about fire safety in the home.

As is true of all first responders, at the firehouse you never know what the day will bring. You never know how you will be called to be of service. We are always happy to lend a helping hand wherever/however needed. In June of 2022 a storm came through the area and knocked out the power to the majority of the Village. The Fire Department worked alongside Mayor Walik to provide "cooling events". The Fire Department was able to join the mayor at locations throughout the town, hooking our equipment to hydrants. This allowed residents to safely cool off in the hydrant's spray while they had no air conditioning due to the loss of power. We were able to provide not only critical cooling but also some fun in otherwise miserable conditions.

We were able to continue with the KNOX box program. This was a program instituted by Mayor Walik. If the seniors ask for one, their house key is locked inside this box and it is hung on the outside of their door. Only the fire department has the access key.

The guys have been working inside the fire house cleaning. The original 21-year-old ceiling tiles have been replaced.

The Stickney Fire Department responded to a total of 1,268 calls in the year 2022 (this is the most calls we have had in 20 years)

Right now, we are hiring. We have a big turnover. We are a steppingstone. We have guys coming in as part time and are called up to a full-time fire department. Some will stay with us and some are told that they can't work part-time in another fire department. One of our newest lieutenants has been deployed to Africa for one year. He is also a Chicago firefighter.

The Mayor explained that if the fire department or police department notice a second fall to a senior that is home alone, we will talk to them or the family about the KNOX box. There is no cost. If someone moves or passes on, the box is returned to the fire department. This allows us to have a count available. The Mayor said that if that count goes below three, they would buy more.

Fire Chief Boyajian told us that the Mayor asked him two months ago to start looking for a ladder truck. They started a committee of five people to start looking for a new ladder truck. The one we are looking at is \$1.3 million. McCook just got one that was \$2 million. We are on a fast track of 13 to 16 months for delivery. To build one it takes 2 ½ to 3 years. Trustee White interjected that we applied for a grant a couple of

weeks ago. The Chief explained that it is the FEMA Assistance to Fire Fighter Grant. Last year's grant is supposed to close in March. He is waiting for a letter updating him on that.

An audience member asked how old is the current ladder truck? The Chief told him that we sold it. It was 27 years old. The Chief talked about everything going up 20% in the last year. We are fortunate that we can buy new things. Other departments are less fortunate, and he does not know how they do it.

The Mayor thanked the Chief for his report and the men and women of the department for doing a great job.

There being no further business, Trustee White moved, duly seconded by Trustee Milenkovic that the meeting be adjourned. Upon which the Board adopted the motion at 7:25 p.m.

ORDINANCE NO. 2023-03

- AN ORDINANCE AUTHORIZING AND APPROVING THE PURCHASE OF CERTAIN VEHICLES FOR THE POLICE DEPARTMENT OF THE VILLAGE OF STICKNEY, ILLINOIS.
- WHEREAS, the Village of Stickney (the "Village") is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and
- WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret and amend its ordinances, rules and regulations; and
- **WHEREAS**, the Village has determined that the Police Department is in need of five (5) Ford Police Interceptors (the "Vehicles") from Morrow Brothers Ford, Inc. as set forth in the invoice ("Invoice"), attached hereto and incorporated herein as Exhibit A; and
- **WHEREAS**, the Village President (the "President") and the Board of Trustees of the Village (the "Board" and with the President, the "Corporate Authorities") deem it advisable and necessary for the efficient operation of the Village and to purchase the Vehicles; and
- **WHEREAS**, the Corporate Authorities have determined that it is necessary, advisable, and in the best interests of the Village and its residents to take all steps necessary to purchase the Vehicles in accordance with the terms of the Invoice;
- NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:
- **SECTION 1: RECITALS.** The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.
- **SECTION 2: PURPOSE.** The purpose of this Ordinance is to authorize the purchase of the Vehicles in accordance with the terms of the Invoice, and to authorize the President or his designee to take all necessary steps to effectuate the intent of this Ordinance.
- **SECTION 3: AUTHORIZATION.** The Board hereby authorizes the purchase of the Vehicles in accordance with the terms of the Invoice; waives any bidding requirements related to the purchase of the Vehicles; authorizes and directs the President or his designee to execute any and all necessary documentation to effectuate the same, with such insertions, omissions and

changes as shall be approved by the President and the Village Attorney; and ratifies any additional actions taken to effectuate the intent of this Ordinance. The Board further authorizes the President or his designee to execute any and all additional documentation that may be necessary to carry out the intent of this Ordinance. The Village Clerk is hereby authorized and directed to attest to and countersign any documentation as may be necessary to carry out and effectuate the purpose of this Ordinance. The Village Clerk is also authorized and directed to affix the Seal of the Village to such documentation as is deemed necessary. To the extent that any requirement of bidding would be applicable to the Vehicles described herein, the same is hereby waived.

SECTION 4. HEADINGS. The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 5. SEVERABILITY. The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6. SUPERSEDER. All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION 7. PUBLICATION. A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 8. EFFECTIVE DATE. This Ordinance shall be effective and in full force immediately upon passage and approval as provided by law.

RESOLUTION NO. 06-2023

A RESOLUTION PROPOSING A REDEVELOPMENT PLAN AND PROJECT FOR, AND THE DESIGNATION OF, THE HARLEM-PERSHING REDEVELOPMENT PROJECT AREA, AND THE ADOPTION OF TAX INCREMENT ALLOCATION FINANCING THEREFOR, CONVENING A JOINT REVIEW BOARD AND CALLING A PUBLIC HEARING IN CONNECTION THEREWITH FOR THE VILLAGE OF STICKNEY, ILLINOIS

Whereas, pursuant to the Tax Increment Allocation Redevelopment Act, as supplemented and amended (the "TIF Act"), the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") of the Village of Stickney, Cook County, Illinois (the "Village"), has determined that it is advisable and in the best interests of the Village and certain affected taxing districts that the Village approve a proposed redevelopment plan for the Harlem-Pershing Redevelopment Project Area (the "Redevelopment Plan") and project (the "Project") for, and designate a proposed redevelopment project area to be known as the Harlem-Pershing Redevelopment Project Area (the "Redevelopment Project Area"), as further described in EXHIBIT A attached hereto, and that the Village adopt tax increment allocation financing for the proposed Redevelopment Project Area; and

Whereas, pursuant to Section 11-74.4-4.2 of the TIF Act, the Village is required to create an interested parties registry for activities related to the proposed Redevelopment Project Area, to adopt reasonable registration rules, and to prescribe requisite registration forms for residents and organizations active within the Village that seek to be placed on said interested parties registry, and the Village Board have heretofore, and it hereby expressly is, determined that the Village has created such registry, adopted such registration rules and prescribed such requisite registration forms and given public notice thereof; and

Whereas, pursuant to Section 11-74.4-6(e) of the Act, 65 ILCS 11-74.4-6(e), the Village is required to provide notice to certain parties specified in the Act and hold a public meeting because the Redevelopment Project Area may contain seventy-five (75) or more inhabited residential units; and

Whereas, the TIF Act requires the Village also to convene a joint review board and conduct a public hearing prior to the adoption of ordinances approving a redevelopment plan and project, designating a redevelopment project area, and adopting tax increment allocation financing therefor, at which hearing any interested person or affected taxing district may file with the Village Clerk written objections to and may be heard orally with respect to the proposed Redevelopment Plan and Project; and

Whereas, the TIF Act further requires that such joint review board consist of a representative selected by each community college district, local elementary school district and high school district or each local community unit school district, park district, township, fire protection district and county that will have authority to directly levy taxes on the property within the proposed Redevelopment Project Area at the time that the proposed Redevelopment Project Area is approved, a representative selected by the Village and a public member (who, if such is available, pursuant to Section 11-74.4-5(b) of the Act, 65 ILCS 11-74.4-5(b) shall be a person who resides within the redevelopment project area) to consider the subject matter of the public hearing; and

Whereas, the TIF Act further requires that the time and place of such public hearing be fixed by ordinance or resolution adopted by the Village Board; and

Whereas, the TIF Act further requires that not less than 10 days prior to adopting such ordinance or resolution fixing the time and place of a public hearing, the Village must make available for public inspection a redevelopment plan or a separate report that provides in reasonable detail the basis for the proposed Redevelopment Project Area's qualifying as a "redevelopment project area" under the Act; and

Whereas, the firm of Ryan LLC (formerly Kane McKenna and Associates, Inc.), has conducted an eligibility survey of the proposed Redevelopment Project Area and has prepared its report ("Report") that the proposed area qualifies as a "redevelopment project area" as defined in the TIF Act, which survey and findings have been presented to the Corporate Authorities; and

Whereas, the Report has heretofore been on file and available for public inspection for at least 10 days in the offices of the Village Clerk as required under the TIF Act; and

Whereas, the TIF Act requires that notice of the public hearing be given by publication and mailing; and

Whereas, the Corporate Authorities have heretofore and it hereby is determined that it is advisable to convene a joint review board and hold a public hearing to consider the proposed approval of the proposed Plan and Project;

NOW THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Stickney, County of Cook, State of Illinois, in the exercise of its home rule powers as follows::

Section 1. Redevelopment Plan and Project Proposed. The approval of the Redevelopment Plan and Project, the designation of the Redevelopment Project Area and the adoption of tax increment allocation financing therefor are hereby proposed.

Section 2. Interested Persons Registry Created. There has been created an interested persons registry (the "Registry") for the proposed Redevelopment Project Area. The Village Clerk was hereby expressly authorized and directed to maintain the Registry for the proposed Redevelopment Project Area.

Section 3. Public Meeting Held. On February 7, 2023, a public meeting was held by the Village pursuant to the TIF Act for the purpose of enabling the Village to advise the public, taxing districts having real property in the redevelopment project area, taxpayers who own property in the proposed redevelopment project area, and residents in the area as to the Village's possible intent to prepare a redevelopment plan and designate a redevelopment project area and to receive public comment. Notices of the public meeting was provided by mail (in both English and Spanish languages) to all required parties pursuant to Section 11-74.4-6(e) of the TIF Act.

Section 4. Registration Rules and Forms. The registration rules for the Registry have been previously approved by the Village and are available from the Village Clerk.

Section 5. Joint Review Board Convened. A joint review board as set forth in the TIF Act is hereby convened and the board shall meet, review such documents and issue such report as set forth in the TIF Act. The first meeting of said joint review board shall be held at 10:00 a.m. on the 24th day of March, 2023, at the Stickney Village Hall, 6533 Pershing Road, Stickney, Illinois. The Village hereby expressly finds and determines that said date is at least 14 days before, but not more than 28 days after, the notice to affected taxing districts hereinafter authorized in Section 8 of this resolution will be mailed.

Section 6. Time and Place of Public Hearing Fixed. A public hearing (the "Hearing") shall be held by the Mayor and the Village Board of the Village at 6:00 p.m. on the 2nd day of May,

2023, at St. Pius Church, 4300 S Oak Park Ave, Stickney, Illinois 60402, for the purpose of hearing from any interested persons or affected taxing districts regarding the proposed approval of the Redevelopment Plan and Project, designation of the Redevelopment Project Area, and adoption of tax increment allocation financing therefor.

Section 7. Publication of Notice of Hearing. Notice of the Hearing, substantially in the form attached hereto as EXHIBIT B, shall be published at least twice, the first publication to be not more than 30 nor less than 10 days prior to the Hearing, in a newspaper of general circulation within the taxing districts having property in the proposed Redevelopment Project Area.

Mailing of Notice of Hearing Authorized. (a) Notice shall be mailed by Section 8. certified mail not less than 10 days prior to the date set for the Hearing, to the person or persons in whose name the general taxes for the last preceding year were paid on each lot, block, tract or parcel of land lying within the proposed Redevelopment Project Area. In the event taxes for the last preceding year were not paid, the notice shall also be sent to the persons last listed on the tax rolls within the preceding three years as the owners of such property. Notice shall also be mailed, on a best effort basis, to all residential addresses located within the proposed Redevelopment Project Area. Notice shall also be given within a reasonable time after the adoption of this resolution by first class mail, on a best efforts basis, to all residential addresses located outside the proposed Redevelopment Project Area and within 750 feet of the boundaries of the proposed Redevelopment Project Area and to those organizations and residents that have registered with the Village for that information in accordance with the registration guidelines herein established by the Village. Notice shall also be given by certified mail to all taxing districts of which taxable property is included in the proposed Redevelopment Project Area and to the Illinois Department of Commerce and Economic Opportunity not less than 45 days prior to the Hearing, and such notice (i) shall advise the taxing bodies represented on the joint review board of the time and place of the first meeting of the joint review board and (ii) shall also include an invitation to each taxing district and the Illinois Department of Commerce and Economic Opportunity to submit written comments prior to the date of the Hearing to the Village, to the attention of the Village Clerk, Village Hall, 6533 Pershing Road, Stickney, Illinois 60402 concerning the subject matter of the Hearing. Each such mailed notice to the taxing districts shall include a copy of the Report, the name of an appropriate person to contact for additional information, and a copy of the proposed Redevelopment Plan.

Section 9. Superseder; Effective Date. All ordinances, resolutions, motions or orders in conflict with the provisions of this resolution are, to the extent of such conflict, hereby superseded. This resolution shall be immediately in full force and effect after passage and approval.

Introduction

This Statement of Work ("SOW") has been made and entered into by and between Axon Enterprise, Inc. ("AXON"), and Stickney Police Dept. - IL the ("AGENCY") for the purchase of the Axon Fleet in-car video solution ("FLEET") and its supporting information, services and training. (AXON Technical Project Manager/The AXON installer)

Purpose and Intent

AGENCY states, and AXON understands and agrees, that Agency's purpose and intent for entering into this SOW is for the AGENCY to obtain from AXON deliverables, which used solely in conjunction with AGENCY's existing systems and equipment, which AGENCY specifically agrees to purchase or provide pursuant to the terms of this SOW.

This SOW contains the entire agreement between the parties. There are no promises, agreements, conditions, inducements, warranties or understandings, written or oral, expressed or implied, between the parties, other than as set forth or referenced in the SOW.

Acceptance

Upon completion of the services outlined in this SOW, AGENCY will be provided a professional services acceptance form ("Acceptance Form"). AGENCY will sign the Acceptance Form acknowledging that services have been completed in substantial conformance with this SOW and the Agreement. Unless otherwise agreed upon by AXON, AGENCY may print and reproduce said documents for use by its employees only.

Security Clearance and Access

Upon AGENCY's request, AXON will provide the AGENCY a list of AXON employees, agents, installers or representatives which require access to the AGENCY's facilities in order to perform Work pursuant of this Statement of Work. Training

Wireless Upload System

If purchased by the AGENCY, on such dates and times mutually agreed upon by the parties, AXON will install and configure into AGENCY's existing network a wireless network infrastructure as identified in the AGENCY's binding quote based on conditions of the sale.

VEHICLE INSTALLATION

Preparedness

On such dates and times mutually agreed upon by the parties, the AGENCY will deliver all vehicles to an AXON Installer less weapons and items of evidence. Vehicle(s) will be deemed 'out of service' to the extent necessary to perform Work pursuant of this SOW.

Existing Mobile Video Camera System Removal

On such dates and times mutually agreed upon by the parties, the AGENCY will deliver all vehicles to an AXON Installer which will remove from said vehicles all components of the existing mobile video camera system unless otherwise agreed upon by the AGENCY.

Major components will be salvaged by the AXON Installer for auction by the AGENCY. Wires and cables are net considered expendable and will not be salvaged. Salvaged components will be placed in a designated area by the AGENCY within close proximity of the vehicle in an accessible work space.

Prior to removing the existing mobile video camera systems, it is both the responsibility of the AGENCY and the AXON Installer to test the vehicle's systems' operation to identify and operate, documenting any existing component or system failures and in detail, identify which components of the existing mobile video camera system will be removed by the AXON Installer.

In-Car Hardware/Software Delivery and Installation

On such dates and times mutually agreed upon by the parties, the AGENCY will deliver all vehicles to an AXON Installer, who will install and configure in each vehicle in accordance with the specifications detailed in the system's installation manual and its relevant addendum(s). Applicable in-car hardware will be installed and configured as defined and validated by the AGENCY during the pre-deployment discovery process.

If a specified vehicle is unavailable on the date and time agreed upon by the parties, AGENCY will provide a similar vehicle for the installation process. Delays due to a vehicle, or substitute vehicle, not being available at agreed upon dates and times may results in additional fees to the AGENCY.
