### February 16, 2010

The Board of Trustees of the Village of Stickney met in regular session on Tuesday, February 16, 2010 at 7:00 p.m. in the Stickney Village Hall, 6533 W. Pershing Road, Stickney, Illinois.

Upon the roll call, the following Trustees were present:

Trustees Lazansky, Mares, Morelli, Schimel, and Walik. Trustee Zeedyk was absent.

Trustee Schimel moved, duly seconded by Trustee Morelli, to approve the minutes of the previous regular session on Tuesday, February 3, 2010.

Upon the roll call, the following Trustees voted:

Ayes: Lazansky, Mares, Morelli, Schimel, and Walik.

President O'Reilly declared the motion carried.

Trustee Morelli moved, duly seconded by Trustee Mares that the bills, approved by the various committees of the Board, be approved for payment, and to approve warrants which authorize the Village Treasurer to draw checks to pay the bills, to be signed by the authorized signers, as provided for by the Ordinances of the Village of Stickney.

President O'Reilly declared the motion carried.

Trustee Morelli moved, duly seconded by Trustee Lazansky, to accept the report of the Department of Transportation, State of Illinois, and indicating Motor Fuel Tax collected for the month of January, 2010 indicating the sum of \$14,699.77.

President O'Reilly declared the motion carried.

Trustee Lazansky moved, duly seconded by Trustee Mares to accept the report from the Illinois Department of Revenue for the month of November, 2009 indicating the sum of \$44,610.42.

President O'Reilly declared the motion carried.

PRESIDENT'S REPORT: This Friday we have a meeting with Cook County Emergency Management to find out if we will receive \$69,000 more in funds from the Justice Grant to use towards police equipment. This is in addition to the money we have already received. Police Chief Kretch will be attending the meeting with the Village President. In addition, we have been notified by Senator Viverito's office and others that we are close to receiving the other half of the funds that the State of Illinois owes us for the Village Hall Grant that was used to build the Village Hall. Speaker Madigan is also working on this.

CLERKS REPORT: A thank you note of appreciation was read to the Stickney Fire Department from McCook's Mayor Jeffery Tobolski for their involvement in the funeral of "JJ" James, a long-time firefighter. A report was given on the Census. A Senate Resolution was read that resolves that all public officials in Illinois are to cooperate fully with the U.S. Census Bureau and assist the Bureau with its efforts to make a complete count in Illinois.

#### TRUSTEE REPORTS:

Trustee Lazansky advised us that when he attended the Midway Airport noise meeting on January 21, 2010 he received the airplane noise complaint telephone number of 1-800-435-9569. He remarked that when the number is called, it is then linked with the Chicago 311 reporting center.

Trustee Mares thanked the audience for coming out to the board meetings. He voiced his opinion that he would like more residents to attend. He said that he worked diligently on the latest newsletter article on Parks and Recreation. The residents should keep the newsletter as a reference to all the activities planned. The web site is a work in progress.

Trustee Morelli moved, duly seconded by Trustee Lazansky to accept the treasurer's report for the month of December, 2009.

Upon the roll call, the following Trustees voted: Ayes: Lazansky, Mares, Morelli, Schimel, and Walik

Nays: None Absent: Zeedyk

President O'Reilly declared the motion carried.

Trustee Morelli gave the January fire department report. There were total 159 calls, 86 fire and service calls, and 73 ambulance calls. In 2010 they have responded to 159 calls.

Trustee Walik reminded people of the May 1, Village open house. He thanked Supervisor Joe Lopez for the outstanding job done on the snow removal during the recent storm.

#### **DEPARTMENT REPORTS:**

Fire Chief Meyer advised us that a couple of the firemen went to "Tackle the Tower", the Lung Association fund raiser, in Oak Brook Terrace. Our team came in second in the 31 floor race. Our fire department went to assist Cicero at a fatal house fire. Since that has happened, there have been questions about overcrowding in homes. He related to a Cicero Federal Government law suit ruling that claimed it was discriminatory to limit the amount of people living in a home. We don't know what is actually going on in private dwellings. During this particular fire, oxygen tanks that were used by an inhabitant in the home exploded and went through a wall and injured a firefighter. This firefighter is still in the hospital.

Police Chief Kretch spoke about the parking tickets and reported that 95% to 96% of the residents understand the parking regulations. The remaining 5% still do not understand it. His goal is not to write any tickets. It is not his intention to use this to make money. Ordinance Officer Torres and he are taking heated phone calls about the tickets given out. The police department is using the reverse 911 system to contact people when it snows on the days they usually have street sweeping.

Public Works Supervisor, Joe Lopez announced that we had nine plus inches of snow last week. There were equipment failures on a few of our trucks. The repairs were quickly made. In addition, he personally contacted the Illinois State supervisor named Frank about complaints received over the plowing of Pershing Road. Supervisor Lopez instructed him about what we expect of them. He was assured that the State driver has been instructed on how he will plow Pershing in the future. President O'Reilly informed us that the police took pictures of the homes that were sprayed by the plowing. The pictures will be sent out with a letter requesting that the homes should be cleaned by the State. We learned that no windows were shattered as they had been in the past.

#### **AUDIENCE QUESTIONS:**

Mrs. Bea Callahan, of 4126 Grove Ave. questioned the reverse 911 system. She wanted to know how many times it has been used. The response was that it has been utilized three or four times. She was concerned that her home has never received such a call. We have informed the residents at the board meetings and in the newsletter to notify the police of their phone numbers for any reverse 911 alerts. Police Chief Kretch informed her to go to the police station and provide her home phone number or cell phone number to be added to the list of contact numbers.

There being no further business, Trustee Lazansky moved, duly seconded by Trustee Walik that the meeting be adjourned. Upon which the Board adopted the motion at 7:16 p.m.

#### ORDINANCE NO. 2010-04

AN ORDINANCE AMENDING CHAPTER 14, "MOTOR VEHICLES AND TRAFFIC", OF THE ORDINANCES OF THE VILLAGE OF STICKNEY, ILLINOIS BY REVISING ARTICLE III, DIVISION 7, "STOPPING, STANDING AND PARKING."

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT AS FOLLOWS:

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, THE Village of Stickney seeks to maintain the safety and appearance of the streets and roadways throughout the Village; and

**WHEREAS**, the Village of Stickney maintains certain regulations of the streets and sidewalks and enforces certain regulations of the State of Illinois; and

**WHEREAS**, the President and Board of Trustees of the Village of Stickney seek to raise the administrative fee charged to remove the immobilization equipment on vehicles that are involved in prohibited activities to be equal to the rate charged in the village's surrounding communities.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEE OF THE VILLAGE OF STICKNEY. COOK COUNTY. ILLINOIS.

**Section 1. Recitals.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2. Adoption**. Chapter 14 Article III, Division 7 of the Municipal Code of the Village of Stickney shall be amended to read as follows:

#### Sec. 14-141. Removal of illegally parked vehicles.

- (a) The police department and all members thereof assigned to traffic duty are hereby authorized to remove and tow away or have removed and towed away by commercial towing service, any car of or other vehicle illegally parked in any place where such parked vehicle creates or constitutes a traffic hazard, blocks the use of a fire hydrant or obstructs or may obstruct the movement of any emergency vehicle; or any other illegally parked vehicle which has remained in any public street or any other public place for a period exceeding 24 continuous hours.
- (b) Cars so towed away shall be stored on any city <u>Village</u> property or in a public garage or parking lot and shall be restored to the owner or operator thereof after payment of the expense incurred by the Village in removing and storing such vehicles.
- (c) In lieu of or in addition to other remedies provided for under these codified ordinances, the police department is hereby authorized to use immobilization equipment on any vehicle found to be in violation of any of the provisions of these codified ordinances, including vehicles found parked in any parking lot without a proper vehicle sticker and vehicles found parked in violation of parking meter or limited parking regulations.

- (1) The use of such equipment is authorized for the purpose of reducing or eliminating costs of towing, impounding and inventorying such vehicles, reducing the additional time and expense concerning the issuance of tag-on citations and the processing of the same and deterring would-be "scofflaws" from consistent violations of these codified ordinances.
- (2) No person shall injure, damage or otherwise destroy any immobilization equipment belonging to the police department and attached to any vehicle.
- (3) Within 72 hours of the placement of any immobilization equipment, if the owner of the vehicle does not contact the police department and the equipment in still on the vehicle, the Village and the police department are authorized to tow the vehicle at the owner's expense, including the following described expenses: The cost to remove the immobilization equipment shall be \$100.00, plus the cost of any outstanding citations and/or traffic or parking violations and towing charges. A \$25.00 per day storage fee for vehicles stored on Village property.
- **Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.
- **Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.
- **Section 5. Conflicts.** This Ordinance supersedes all ordinances or parts of ordinances directly conflicting with the terms and provisions contained herein, but only to the extent of such conflict.
- **Section 6. Severability.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.
- **Section 7. Certification and Publication.** The Village Clerk of the Village of Stickney shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.

#### **ORDINANCE NO. 2010-05**

AN ORDINANCE AMENDING CHAPTER 14, "MOTOR VEHICLES AND TRAFFIC", OF THE ORDINANCES OF THE VILLAGE OF STICKNEY, ILLINOIS BY REVISING ARTICLE III, DIVISION 7,STOPPING, STANDING AND PARKING, BY ADDING SECTION 14-159.2, "FOUR-HOUR PARKING."

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT AS FOLLOWS:

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, the Village of Stickney seeks to maintain the safety and appearance of the streets and roadways throughout the Village; and

**WHEREAS**, the Village of Stickney maintains certain regulations of the streets and sidewalks and enforces certain regulations of the State of Illinois; and

**WHEREAS**, the President and Board of Trustees of the Village of Stickney seek to change the rules ,and procedures.

**RESOLVED:** NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEE OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS.

**Section 1. Recitals.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2. Adoption**. Chapter 14, Article III, Division 7, by the addition of Section 14-158.2 to the Municipal Code of the Village of Stickney as follows:

#### Sec. 14-158.2, Four-hour parking.

No person shall park a vehicle for a period in excess of 240 consecutive minutes between the hours of 8:00 a.m. and 8:00 p.m. at the following location:

The south side of 40<sup>th</sup> Street "off-street parking area" from the east curb line of Grove Avenue to the west curb line of Oak Park Avenue.

- **Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.
- **Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.
- **Section 5.** Conflicts. This Ordinance supersedes all ordinances or parts of ordinances directly conflicting with the terms and provisions contained herein, but only to the extent of such conflict.
- **Section 6. Severability.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent

jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**Section 7. Certification and Publication.** The Village Clerk of the Village of Stickney shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.

#### ORDINANCE NO. 2010-06

AN ORDINANCE AMENDING CHAPTER 14, "MOTOR VEHICLES AND TRAFFIC", OF THE ORDINANCES OF THE VILLAGE OF STICKNEY, ILLINOIS BY REVISING ARTICLE III, DIVISION 7,STOPPING, STANDING AND PARKING, BY AMMENDING SECTION 14-158.1 "TWO-HOUR PARKING".

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT AS FOLLOWS:

**WHEREAS**, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, the Village of Stickney seeks to maintain the safety and appearance of the streets and roadways throughout the Village; and

**WHEREAS**, the Village of Stickney maintains certain regulations of the streets and sidewalks and enforces certain regulations of the State of Illinois; and

**WHEREAS**, the President and Board of Trustees of the Village of Stickney seek to change the rules ,and procedures.

**RESOLVED:** NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEE OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS.

**Section 1. Recitals.** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section 2.** Adoption. Chapter 14, Article III, Division 7, by amending Section 14-158.1 of the Municipal Code of the Village of Stickney as follows:

#### Sec. 14-158.1 Two-hour parking.

No person shall park a vehicle for a period in excess of 120 consecutive minutes in any of the following locations:

Pershing Road, south side, from Grove Avenue to <u>Euclid-Wesley</u> Avenue <u>and Scoville</u> <u>Avenue to Gunderson Avenue.</u>

- **Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.
- **Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.
- **Section 5. Conflicts.** This Ordinance supersedes all ordinances or parts of ordinances directly conflicting with the terms and provisions contained herein, but only to the extent of such conflict.

**Section 6. Severability.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**Section 7. Certification and Publication.** The Village Clerk of the Village of Stickney shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.
