The Metropolitan Water Reclamation District of Greater Chicago made a presentation to the Board of Trustees concerning their Rain Barrel Program. Representative Edward Staudacher P.E. gave an explanation of their program. They are encouraging homeowners to disconnect their rain downspouts that are directly connected to the sanitary sewer system and use the rain barrel program. Details were given. The village is being asked to sign on with the program.

Trustee Lazansky moved, duly seconded by Trustee White to approve the agreement for the Rain Barrel Program with the Metropolitan Water Reclamation District of Greater Chicago.

MAYOR REPORT: Mayor Morelli wished Happy Thanksgiving greetings to everybody.

CLERKS REPORT: Clerk McAdams informed everyone that she will be posting the 2015 Consolidated Election Petition Filing dates later this week.

Trustee Gomez gave Thanksgiving greetings. She mentioned that the Children's Christmas party will be December 6, at the Stickney Recreation Center. The Senior Christmas party will be on December 6, at 11:00 a.m. to 1:00 p.m.

Trustee Lazansky and Trustee White gave Thanksgiving greetings.

DEPARTMENT REPORTS: Police Chief Sladetz mentioned that the police department statistics for DUIs are going up. The crime rate is holding its own. Our squad maintenance is going up. Our fleet of cars is getting old. One of our frontline vehicles had four new cam shafts installed. Fortunately there was six hundred miles left on the 100,000 mile warranty. He is going to do his best to keep the fleet running during the winter. He gave Thanksgiving greetings.

Public Works Supervisor Jeff Boyajian mentioned that some people have been raking their leaves into the street. They are not allowed to do that. Even though public works is using a truck with a front-end brush, the intention is to elevate the fallen leaves in the street, not physically pick up piles of leaves. He reminded us that with two inches of snow people must move their cars on the even days to the even side and on the odd days on the odd side of the street. Next week is a short work week due to having Thursday and Friday off. All Thursday pickups will be done on Wednesday.

Fire Chief Meyer reported on more maintenance issues on their equipment. Tires alone can cost \$1,000 each. The springs have to be custom made. He addressed the Turanto Bakery fire they help extinguish. A propane tank fell over during maintenance and caused the fire. The fire department also attended a fire at Carson's in North Riverside. An electric heater shorted out on the dock causing a fire that will shut down the store until the rest of the year due to smoke damage.

Treasurer Kurt Kasnicka informed us that the Village administrative offices will be closed on Thursday and Friday due to Thanksgiving.

There being no further business, Trustee Lazansky moved, duly seconded by Trustee Gomez that the meeting be adjourned. Upon which the Board adopted the motion at 7:20 p.m.

Trustee Lazansky moved, duly seconded by Trustee Sleigher to pass and approve Option 1: of Ordinance 2014-10, "The 2014 Tax Levy Ordinance for the Fiscal Year, beginning May 1, 2014 and ending April 30, 2014.

Option 1: Increase to General Fund of \$25,000.00 and increase to Police Pension Fund of \$14,907.00 and is based on Ordinance #2014-6 Annual Budget and Appropriation Ordinance

Option 2: No increase to General Fund and increase to Police Pension Fund of \$14,907.00

Option 3: No increase to General Fund and no increase to Police Pension fund

Upon the roll call, the following Trustees voted:

Mayor Morelli declared the motion failed

Trustee White moved, duly seconded by Trustee Savopoulos to pass and approve Ordinance 2014-10, Option 2.

Upon the roll call, the following Trustees voted:

Mayor Morelli declared the motion carried.

Prior to the vote on the first motion on Option 1 Trustee De Leshe questioned what does the actuarial state that should be required? Treasurer Kasnicka answered that the actuarial amount was at \$590,000 but it was a few years ago that they changed the assumptions to a 40-year period to the year 2040. With that the amount is lower. One of the things is we are within the \$600,000 range of what we are levying. Now, what we are going to be paying out this year is just over \$800,000 in pension salaries. The latest actuarial stated that we have dropped a couple of tenths of a percent. We are still funded at 38% of being funded. We are ahead of what Tim Sharp, our actuarial, recommends that what we levy. This (the budget increase) will help us catch up to the \$600,000 and surpass that in the short term. Trustee White asked about the law where the state can seize our state-raised revenue. Kasnicka said that we are OK because the amounts that are needed to levy are in the \$500,000 range. We are not in jeopardy for the police pension fund where they would take our state-shared revenues. We were at 38% funded. We are to be fully funded by 2040. Trustee De Leshe asked what the percentage would be in 2016. Kasnicka said we are ahead of where we are required to levy. Trustee White asked what the reason was that we are short was because of retirements or are we paying out more money. Is that what you are saying? Kasnicka explained that there are a lot more factors. We have been stuck in the 35% to 40% range for years. All that is calculating out is an estimate of all future benefits. They are looking at what do we have on hand and our fund and they are looking at the money will earn at 7% rate of return. Of course, he said, we are not because of the limitations with so much ca being invested in equities and half can be in bonds. We are not earning 7% and therefore we are not achieving the rate of return that the assumptions say it should.



Trustee De Leshe asked why we can't take the \$25,000 you propose for the General Fund and put it also in the Police Pension Fund. The Trustee stated that it has been stated in an article that we have one of the worst funded pensions in the state. Kasnicka explained that the expenses of the village go up and you have to have revenues to keep up because the expenses keep going up. That is why the \$25,000 is in for the General Fund purposes. He said that he is giving you options to balance the General Fund. He went on to say that we are projected to have a deficit in the General Fund of \$300,000. What happens every year the expenses keep going up. Trustee De Leshe assumed that the \$14,907.00 was just enough to keep up with the Pension Fund. The Treasurer said that the amount that we recommended last year was around \$597,000. Therefore, there was no increase last year. Last year we were targeting \$612,000 and 2% of that is \$12,000. Trustee Gomez challenged Kasnicka by asking if this being the ultimate answer. She didn't want to hear later that you changed your mind, whatever. Kasnicka reiterated that we are 38% funded and we are talking about millions of dollars and \$14,907 is like petty cash. What we are trying to do is to keep pace with the actuarial. As the years go on it is going to see increases of a lot more than the \$15,000. Trustee Savopoulos asked why we are short by \$300,000 in the General Fund. Kasnicka said that it is \$300,000 more in expenses than we are expecting in revenue. Trustee Savopoulos stated that two years ago we had \$700,000 in surplus in the General Fund. Kasnicka said that in May, 2009 the Village had \$2.2 million in fund balance. In April of 2013 a third of those reserves are gone. This last year we had a surplus of \$82,000. We didn't fund anything to Capital Projects. If you go back to the last six years, expenses keep going up about \$175,000 to \$200,000 every year. Trustee Savopoulos questioned what we are doing to control the spending. Kasnicka felt that now we don't have a group of people who are going out spending. The department heads feel that we can get by. Kasnicka referred to the Menard's file history. This really adds up. The Mayor granted permission for Bea Callahan in the audience to speak. She asked if we really had to spend over \$100,000 to fix the computers and licensing. Trustee White corrected her by saying that it was actually \$200,000. He said that it was a lot more than we were originally told. He went on to say that we spent \$200,000 on trees. We cut down every tree and took out the stumps. The treasurer refocused the conversation to the tax levy. He reiterated the explanation of the Options. It was at this point that a vote was made on the first motion for Option 1. Option 2 was then voted on after Trustee White made the motion.

Trustee Sleighter moved, duly seconded by Trustee Lazansky to pass and approve Ordinance 2014-11, "An Ordinance Amending Solid Waste Collection Fee".

Mayor Morelli declared the motion failed

Prior to the vote Treasurer Kasnicka explained that this is a \$3.00 per month increase from \$12.00 to \$15.00. It would generate approximately \$60,000 on a yearly basis. Trustee De Leshe asked why they are asking for the increase. Kasnicka said that the last time the rates were changed was in 2007. We have the lowest garbage



rate in the area. This will generate an increase in the General Fund. This was in the budget to raise the rates to raise more revenue. He went on to say that we have an aging fleet of garbage trucks. Trustee White asked the audience who would like their garbage rates raised. Not one person raised their hands. Various comments were given during an open conversation. Trustee Lazansky gave input about the rates being low. He even stated that the vehicle sticker prices are the lowest in the area at \$20.00 where other communities are \$75.00. Trustee De Leshe gave his opinion about earmarking any raises to go toward the purchase of a garbage truck. He asked Supervisor Boyajian what a garbage truck would cost. We learned that it is \$210,000 and we will need a new truck in five years. Treasurer Kasnicka stated that what you are trying to achieve is to make enough revenue to have enough money to transfer it over to the Capital Projects Fund so that when the garbage truck needs to be purchased you would have money on hand. Previously \$250,000 was transferred over from the General Fund into the Capital Projects Fund. It was a great plan but there were no provisions for revenues. He went on to say that the fund balance went down from \$2.2 million to \$1.5 million in a four year period. Now we have brought it up to \$1.6 million. When the garbage trucks come up, where are you going to get the money? He felt that the ambulance fees should be saved in a fund for an ambulance. But, the money gets spent. Trustee White reminded everyone that we were told that we had the money for an ambulance and now we are told there is no money for an ambulance. Kasnicka gave his projections for the ambulance. The park project status was given. The front stairs at the police department were discussed. Trustee Sleighter lamented that we cannot do anything unless we get grants. We can't do anything for the people unless we get grants.

Trustee Lazansky moved, duly seconded by Trustee Sleighter to pass and approve Ordinance 2014-12, Providing for the Issuance and Sale of Not to Exceed \$1,500,000 of General Obligation Bonds Series 2014 for the Purpose of Refunding the \$850,000 Outstanding Aggregate Principal Amount of General Obligation Bonds, Series 2004"

Upon the roll call, the following Trustees voted:

Mayor Morelli declared the motion carried.

Prior to the vote a presentation was made by Bill Hofherr of George K. Baum explained at length the refunding of the 2004 bond. There will be \$500,000 in new money and refunding, it makes sense. The 2008 and 2011 are callable in 2018. There you have \$5.5 to \$6 million and those would be candidates given their size. A majority of his presentation was similar to one given at a previous meeting. Attorney Kreger added that this plan will not raise the levy. The levy will go up slightly for the next three years if we don't refinance. He said that this is a way to raise funds without raising taxes. Trustee Sleighter asked about the fees. We were told that the total fees would be \$40,000 payable from the proceeds. The fee to George K. Baum is \$13,000, \$1,000 for the Depository Trust Company and \$16,000 to Attorney Donald Kreger. Trustee Savopoulos asked about the savings. Bill Hofherr told us that it will save \$20,000 to \$30,000 over all. This will hold down the taxes for four years. Trustee De Leshe asked where the \$500,000 will be used. Attorney Kreger told us that it has to go into the Bond Proceeds and it is used for Capital Expenditures.

Treasurer Kasnicka reminded us that if this passes it will go into the Capital Fund and we can then get the public works truck.

Trustee Sleighter questioned the grant that we are to receive for the playground. He wanted clarification as to where those funds will go. Kasnicka explained that those funds will have to go back into the Capital Project Funds. Attorney Kreger continued the discussion by explaining the Capital Projects Fund is currently being funded by the General taxes. You earmarked it. This board can un-earmark it. You are not legally bound (unlike bond proceeds where you are legally bound to spend it on and that is Capital Projects so that the bond issue is tax exempt.)

Attorney Kreger explained to Trustee Savopoulos that your taxes will not be going up. The current levy covers your payback for four years and the refinancing of the others will cover the payback entirely. The total design is to say that your taxes are not going to go up and still function with some type of new money available and earmarked for it. There isn't going to be another tax. One tax is cancelled.

There was a lack of a motion on Ordinance 2014-13, "Amending Motor Vehicles and Traffic as it pertains to eliminating residential parking zone A". The ordinance failed.

There was discussion led by Attorney Kreger explaining that we had passed an ordinance creating residential only parking on Clinton Avenue from 39<sup>th</sup> to 40<sup>th</sup> on both sides of the street. Resident, Gabriel Rangel of that block was allowed to speak before the board at this time. He explained that he was the one to canvas his block originally. They were having parking problems due to the apartment buildings taking up all the street parking. He obtained signatures of his neighbors asking the board to help the parking problem by creating a resident-only parking zone. An ordinance was passed creating such a zone. Next thing he knows, a lady came to his door and had a petition to overturn that resident-only parking ordinance due to visitors not being able to park on the block. Mr. Rangel gave multiple examples of the need for the resident-only ordinance. He wanted to know why this is coming up when you already passed the resident-only parking ordinance. Treasurer Kurt Kasnicka explained how the "A" parking sticker will work. He said, that anyone that lives on that block and has a car registered there, will get the "A" parking sticker. What we have done in the other resident-only parking areas is that we give each house two parking passes. You can have more at a cost of \$5.00 each. If you need a replacement card, it is \$5.00. Considerable more conversation was held. Trustee De Leshe questioned if we have the proper signs and stickers so the original ordinance can go into effect. Everything is in place to go ahead with the resident-only parking zone "A".

Trustee White moved, duly seconded by Trustee Savopoulos to pass and approve Ordinance 2014-14, Amending Video Gaming License fee.

Mayor Morelli declared the motion carried.

Prior to the vote Attorney Kreger explained that we are raising the rate to conform to what has been on our applications.

Trustee Lazansky moved, duly seconded by Trustee Sleighter to pass and approve Ordinance 2014-15, Amending Law Enforcement by adding an Additional Corporal,"

Upon the roll call, the following Trustees voted:

Mayor Morelli declared the motion carried.

Prior to the vote, Police Chief John Sladetz educated us on the fact that they are projecting to implementing 12-hour shifts. There will be a sergeant on each team. We already have two corporals. We would like to get a third corporal. If a sergeant is off we will have a ranking supervisor to oversee that shift. What this does is elevate a lot of premium pay if you are paying a patrolman to be a shift commander for the eight-hour shift. You are actually paying him a sergeant's salary. It would save probably \$8,000 per year. Trustee De Leshe asked if it is an appointed position.

Trustee Lazansky moved, duly seconded by Trustee Sleighter to pass and approve Resolution 06-2014, " A Resolution to increase Loss of Bond & Interest Fund to 8% for the 2014 tax year."

Upon the roll call, the following Trustees voted:

Ayes: Trustees De Leshe, Gomez, Lazansky, Savopoulos, Sleighter and White

Nays: None

Mayor Morelli declared the motion carried.

Treasurer Kasnicka explained prior to the vote that would produce \$23,000 increase in revenue. He told us that when he made the bond payment on December 1, we were short just under \$74,000. This is down a bit from last year. This goes back to the big refunds to Hawthorne Race Course and the amount that was prorated to the bond and interest fund. Every year when we go to pay the bond and interest fund, we are short. This is for consideration for one year only. It will start to close the gap so we don't have to borrow the money. Trustee Sleighter asked what it will cost anybody. Kasnicka said that it will be .73% increase in taxes. In your tax bill where you pay \$1,000 to the Village of Stickney, it will cost you \$7.30 and it is a one-time shot. Unless it is brought up for future years. Attorney Kreger went on to tell us that if someone objects to their Equalized Assessed Evaluation and the decision is made during the year they are seeking it, it wouldn't have the impact on us. Since we are Home Rule, whatever we levy we are supposed to get. If someone gets a refund after the year of collection, it has the impact of reducing the money we get and we can't make up for it. For instance, the race track was not decided for six years and we had to return and not get replacement funds. We currently have two cases now. We are working with the school district now and we are hoping objections are not successful. The treasurer clarified that when he goes to pay the bonds and there is not enough money, he has to make a temporary loan and when the taxes start to come in during the first installment and he starts to pay back the temporary loan. Every year we get in the same position.

Trustee White moved, duly seconded by Trustee Savopoulos to approve Mutual Box Alarm System Addendum Agreement.

Fire Chief Larry Meyer enlightened the board that this is MABAS. This is the box alarm system that is used in all fire departments in the regional states. This is an agreement by all fire departments to provide aid in times of need. He used an example of when Hurricane Katrina hit, we had two of our people go there for ten days to help. FEMA reimbursed us. This document is changing some of the contact reimbursement language.

Trustee Gomez moved, duly seconded by Trustee White to grant permission to the Girls Scouts of Greater Chicago and Northwest Indiana to conduct their cookie order program Jan. 1-25, 2015 with delivery starting February 18, 2015. Cookie direct sale booths will take place between February 3, 2015 and May 1, 2015.

That is delegating to a private entity amendments to our ordinance purely by changing some model code. We have to adopt a particular year and three years later when they come in with new we have to decide whether adopt the new one or stay with the old one.

**CLERKS REPORT:** Clerk McAdams referred to a flyer that she placed in the lobby informed everyone that Com Ed is providing a \$1,500 grant to seniors who are past-due on their electric bill. ## ORDINANCE NO. 2015-01

### AN ORDINANCE AMENDING CHAPTER 18 OF THE MUNICIPAL CODE OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS (PLUMBING CODE)

**WHEREAS**, pursuant to the Illinois Plumbing License Law (225 ILCS 320) the Illinois Plumbing Code is by operation of law applicable to the installation, alteration and use of plumbing in the Village of Stickney of the State of Illinois.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Stickney, Cook County, Illinois, by and through its home Rule Powers, as follows:

**Section 1.** That the above recital and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** Section 18-221 (*"Adopted"*) of Article VI (*"Plumbing Code"*) of Chapter 18 (*"Buildings and Building Regulations"*) of the Municipal Code of Stickney, Illinois is hereby amended to read as follows:

**Sec. 18-221. Applicable Plumbing Code.**

- (a) ~~The most current available edition of the provisions of the Municipal Code of the City of Chicago~~ Illinois Plumbing Code, 77 Illinois Administrative Code, Part 890, ~~relating to plumbing, are~~ is hereby adopted by reference and shall be deemed to be applicable to the installation, alteration and use of plumbing in the Village of Stickney. Three copies of the most current available edition of the ~~City of Chicago~~ Illinois Plumbing Code shall be maintained in the office of the Village Clerk and are available for public inspection.
- (b) It shall be unlawful for any person to violate any of the provisions of the Illinois Plumbing Code.

**Section 3.** Section 18-222 (*"Definition"*) of Article VI (*"Plumbing Code"*) of Chapter 18 (*"Buildings and Building Regulations"*) of the Municipal Code of Stickney is hereby repealed.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance

are hereby repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

The Village Attorney and Building Official are hereby directed to provide the appropriate notice for a public hearing and to provide notice to the owners of the property located within the Subject Property.
