The Chief announced that the spring season fire hydrant flushing is taking place. The residents will be notified via our

Code Red system. There will be sediment in the water. The flushing keeps the hydrants flowing. Finally, the new ambulance is here. The inspector has approved it. It should be in service by the end of the week.

SUBJECT: SUMMARY OF TERMS OF LEASE AGREEMENT

This memorandum summarizes the key terms of the proposed Lease Agreement (the "Lease") by and between the Village of Stickney (the "Village") and the Metropolitan Water Reclamation District of Greater Chicago ("MWRD"). It is our understanding that the Village's prior counsel reviewed and negotiated the terms of this Lease and, as such, this memorandum is merely intended as a summary of the final, key terms as presented.

<u>Term</u>: The term of the Lease is five (5) years, commencing November 20, 2015. MWRD may terminate the Lease upon one (1) year's written notice.

Rental Fee: The total rental fee under the Lease is \$10.00, which MWRD acknowledges receiving. The Village is also responsible for the payment of all water rates, taxes, charges, assessments and levies imposed on the Leased Property (as defined below). Within thirty (30) days after the effective date, the Village is required to provide notice of the Lease to the Cook County Assessor.

<u>Leased Property</u>: The "Leased Property" is 63.7 acres of vacant real estate located east of Ridgeland Avenue, south of 39<sup>th</sup> Street to 41<sup>st</sup> Street, and including Lombard Avenue, between 39<sup>th</sup> Street and 43<sup>rd</sup> Street. The Leased Property is generally depicted on Exhibit C to the Lease. The Village agrees to procure, at its expense, a survey and legal description of the Leased Property within twenty one (21) days after the execution of the Lease to supplement the description of the Leased Property.

<u>Permitted Uses</u>: The only permitted uses of the Leased Property are recreational purposes, including a Village festival and similar events, carnivals and fireworks displays no more than three (3) times per year, a baseball field, a Veteran's War Memorial, public park and recreational activities. No other uses are permitted. The sale, distribution and consumption of alcoholic beverages on the Leased Property are specifically prohibited.

<u>Signage</u>: The Village agrees to construct, erect and maintain signage at the Leased Property stating as follows: "THIS FACILITY IS PROVIDED IN PART AS A COMMUNITY SERVICE WITH THE COOPERATION AND SUPPORT OF THE METROPOLITAN WATER RECLAMATION DISTRICT OF GREATER CHICAGO." The signage must be approved by MWRD.

<u>Insurance</u>: The Village is required, prior to using the Leased Property, to provide a certificate of insurance to MWRD evidencing that the Village maintains comprehensive general liability insurance and all risk property insurance coverages with policy limits of at least \$4,000,000 per occurrence, and naming MWRD as a loss payee.

<u>Indemnification</u>: The Village agrees to assume all responsibility for and defend, indemnify, save and keep harmless MWRD from claims related to injury or property damage arising in connection with the Village's use of the Leased Property and for costs and expenses related to environmental clean-up, any environmental investigation, the release of hazardous materials and the migration of hazardous materials to adjacent properties.

Environmental Provisions: As a prior lessee of the Leased Property, the Village warrants and represents that, to the best of its knowledge, the Leased Property is free from contamination by hazardous materials, during the period of its use of the Leased Property, there have not been any releases, discharges or emissions of hazardous materials, and that there are no underground storage tanks, land disposal sites, or dumps at the Leased Property. The Village agrees to remove and remediate the Leased Property in the event of a release, emission, discharge or disposal of a hazardous material during the term of the Lease unless the condition is caused by MWRD. MWRD may require the Village to obtain, at the Village's cost, Phase I and Phase II environmental studies of the Leased Property if MWRD has a reasonable suspicion of the presence of hazardous materials.

Within sixty (60) days after the execution of the Lease, the Village is required to submit to MWRD a general statement of the activities it will conduct on the Leased Property. The Village agrees to conduct daily monitoring, and maintain a log, to ensure compliance with environmental laws.

If the Village does not renew the Lease at least eighteen (18) months prior to its expiration, the Village will be required to post a bond in the amount of \$10,000 to secure performance of any environmental remediation required at the Leased Premises. Not less than one (1) year prior to the expiration of the Lease, the Village will have a written site assessment prepared by a licensed engineer summarizing the environmental condition of the Leased Property.




