Reports from Trustees:

Trustee Mares reported on up-coming events with the Parks & Recreations program. He extended his wishes for all to have a great Memorial Day weekend.

Trustee Schimel updated us with the on-going plague of foreclosures. His good news was that over the last two to two and a half weeks many foreclosed homes are actually moving. They are going for very low prices. He felt we were doing far better in home sales in comparison to adjoining communities. He hoped that home sales for homes not involved with foreclosures would also sell.

Fire Chief Larry Meyer reported that all the hydrant flushing has been completed. He advised us that the fire department trenching drills have ended. He asked if a letter with a reimbursement of \$9358.93 from the State of Illinois has arrived. There was notice sent to him that the fire department would get a fraction of their original outlay of money towards training of the firemen.

Police Chief Joe Kretch alerted us to the reincarnation of the Police Bike Patrol. In addition he provided insight to a new dedicated Police Department web site. This web site will provide a brief biography for each police officer such as where there come from, their background and their education.

A woman in the audience questioned the safety of the police officers when giving their personal information on a web site. Chief Kretch explained that the information would not be that personal. It would give facts such as their background, and where they were trained.

The Chief continued to explain that many of the officers are very well educated with significant certifications.

Kurt Kasnicka, the Village Treasurer, gave his report. He reminded us that the Village Hall is closed on Memorial Day, May 25. He then presented a fine, framed number one vehicle sticker to President Daniel O'Reilly. Treasurer Kasnicka then gave the pertinent information of the sale dates and when the extended hours would be.

Fire Chief Meyer reminded us of the May 24th Combined Veteran's Parade that will be in Stickney.

Village Supervisor of Public Works and the Water Department, Joe Lopez, announced that there will be no pick-up services on Monday. All the regular services will be delayed by one day.

Our Village engineer, Tim Geary of Frank Novotny Engineers, gave us a status report on the construction of the streets and sewers. He expected the current project to be complete by the end of July.

Trustee Mares requested that people be aware that he is looking for volunteers to help with the recreation program. Trustee Lazansky questioned if this would satisfy community service hours for our youth. President O'Reilly had already questioned Ordinance Officer Torres and he learned that volunteering could be used toward community service hours.

Trustee Lazansky thanked Police Chief Kretch for sending a police representative to Riverside to observe his son receiving the Police Patrolman of the year award.

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, A HOME RULE UNIT OF GOVERNMENT, AS FOLLOWS:

WHEREAS, the Village of Stickney (the "Village") is a home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village currently uses the BOCA National Building Code, 1999 Edition, with certain additions, deletions, and changes as its building code;

WHEREAS, the Village wishes to update its building code to reflect changes and improvements in construction standards and practices;

WHEREAS, the Village has determined that adoption of the International Building Code, as created and published by the International Code Council, will serve to ensure the safety and wellbeing of the Village's residents;

WHEREAS, this Ordinance advances the goal of maintaining the Village as a good and safe place to live.

NOW THEREFORE BE IT ODRAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COUNTY OF COOK, ILLINOIS.

- **Section 1. Recitals.** The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.
- **Section 2.** Adoption. Chapter 18, Article III, Section 18-101 of the Municipal Code of the Village of Stickney shall be amended to read as follows:

Sec. 18-101. Adopted.

(a) That certain document, three copies of which are on file in the office of the village clerk, being marked and designated as the "BOCA National Building Code/1999 edition," "International Building Code," current edition, as published by the Building Officials and Code Administrators International, Inc. International Code Council, is hereby adopted as the building code of the village for the control of buildings and structures as provided in this chapter. Each and all of the regulations, provisions, penalties, conditions and terms of the BOCA National Building Code/1999 edition, International Building Code, current edition, are hereby referred to, adopted and made a part hereof, as if fully set out in this Code, with the additions, insertions, deletions and changes, if any, described in this article.

- (b) It shall be unlawful for any person to violate any provision of the publication adopted in subsection (a) of this section.
- **Section 3. Home Rule.** This ordinance is enacted under the Home Rule powers of the Village as set forth in the Constitution and laws of the State of Illinois.
- **Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.
- **Section 5.** Conflicts. This Ordinance supersedes all ordinances or parts of ordinances directly conflicting with the terms and provisions contained herein, but only to the extent of such conflict.
- **Section 6. Severability**. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.
- **Section 7. Certification and Publication**. The Village Clerk of the Village of Stickney shall certify to the adoption of this Ordinance and cause the same to be published in pamphlet form.

WHEREAS, this Ordinance advances the goal of maintaining the Village as a good and safe place to live.

(2) Permit Fees for Concrete and Roofing Work. All concrete work and all roofing work shall have a minimum permit fee of \$25.00

The term "concrete work" as used in this subsection means work involving the laying of cement, asphalt, concrete, or similar material, and includes, but is not limited to, sidewalks, stairs, patios, and garage aprons.

- (3) (2) Moving of building or structures. For moving of any building or structure, the fee shall be \$1,000.00. The permit shall state specifically thereon the route to be taken. No variation from such route shall be permitted, except in cases of extreme emergency; or for other good cause shown.
- (4) (3) Double fees authorized. Where work for such a permit is required is started, or proceeded with prior to obtaining such permit, the fees specified in this section shall be doubled; but the payment of such double fee shall not relieve any persons from fully complying with the requirements of all ordinances in the execution of the work nor from any other penalties prescribed in this section.
