The Board of Trustees of the Village of Stickney met in regular session on Wednesday, January 6, 2015 at 7:00 p.m. in the Stickney Village Hall, 6533 W. Pershing Road, Stickney, Illinois.

Upon the roll call, the following Trustees were present:

Trustee Sleigher moved, duly seconded by Trustee Lazansky to approve the minutes of the previous regular board meeting held on November 18, 2014.

Upon the roll call, the following Trustees voted:

President Morelli declared the motion carried.

Trustee White moved, duly seconded by Trustee Savopoulos to approve the minutes of the previous regular meeting held on December 16, 2014.

At this point Chief John Sladetz introduced our newest Stickney Police Department Corporals Kevin McGuire and Collin Lockridge. The Chief expressed that we have an exceptional police department... the best that he has seen in 29 years. Corporal McGuire and Corporal Lockridge stand out because of their skill in investigations. He mentioned that Corporal Lockridge was called in on New Year's Eve to handle an investigation where he did evidence tech work on a car. He put in 10 hours conducting this investigation. Clerk Audrey McAdams then swore in both of these new Corporals.

MAYOR'S REPORT: She wished all a Happy New Year.

CLERK'S REPORT: The clerk announced that the election lottery took place on January 5, 2015 and the drawing was conducted by Rev. Chris from Faith Community Church. The Village Independent Party was drawn as the first party on the ballot. The Stickney Progress Party will be second on the ballot.

TRUSTEE'S REPORTS: Trustee Lazansky suggested that people go to the State of Illinois web site to look at the new laws that are going into effect in 2015.

Trustee Sleigher explained that he took a tour of Koppers. The \$45 million expansion budget has been reduced to \$9 million. It will be done in three phases as opposed to one big phase. The first phase will be \$9 million and then they will phase after that. It will still happen but not all at one time. According to the chief engineer there is a cash flow problem.

Trustee Savopoulos mentioned that the Tuesday's garbage pick-up will be done on Wednesday.

DEPARTMENT REPORTS: Treasurer Kurt Kasnicka told us that the administrative offices will be closed on Monday, January 19, due to Martin Luther King Day. He also mentioned that bank fees at US Bank were resolved in our favor. The fees were over \$2600 for a month. Those fees were refunded and now the fees are coming in at a little over \$100. Therefore, the fees have been reduced by \$2500 per month in our favor.

Trustee Sleigher moved, duly seconded by Trustee Savopoulos to adjourn into closed session to look into closed session minutes.

RESOLUTION No. R03-2015

A RESOLUTION INITIATING AND REFERRING TO THE ZONING BOARD OF APPEALS PROPOSED AMENDMENTS TO SECTION 8.01 AND 8.02 OF THE VILLAGE OF STICKNEY ZONING ORDINANCE PROVIDING FOR ADDITIONAL USES TO BE PERMITTED IN AREAS DESIGNATED AS BUSINESS DISTRICT AND ADDITIONAL SPECIAL USES WHICH MAY BE PERMITTED IN SUCH BUSINESS DISTRICT

WHEREAS, the Village of Stickney is a home rule municipal corporation in accordance with Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village has the authority to adopt ordinances and to promulgate rules and regulations; and

WHEREAS, the elimination of the Commercial District from the Village of Stickney Zoning Ordinance caused the elimination of certain permitted uses and special uses from all zoning districts within the Village; and

WHEREAS, the Village Board now desires to initiate an amendment to Section 8.01 of the Village of Stickney Zoning Ordinance by adding the uses listed on Exhibit A attached to this Resolution to the list of permitted uses in said section (the "Proposed Amendment to Section 8.01"); and

WHEREAS, the Village Board now desires to initiate an amendment to Section 8.02 of the Village of Stickney Zoning Ordinance by adding the special uses listed on Exhibit B attached to this Resolution to the list of permitted special uses in said section (the "Proposed Amendment to Section 8.02"); and

WHEREAS, the Village Board has determined that it is appropriate and in the best interest of the Village to initiate the Proposed Amendment to Section 8.01 and the Proposed Amendment to Section 8.02 and forward such matters to the Zoning Board of Appeals for a public hearing and a report and recommendation back to the Village Board.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STICKNEY, COOK COUNTY, ILLINOIS, as follows:

SECTION 1: RECITALS. The facts and statements contained in the preamble to this Resolution are found to be true and correct and are hereby adopted as part of this Resolution.

SECTION 2: INITIATION AND REFERRAL OF PROPOSED AMENDMENTS. Pursuant to the applicable provisions of the Village of Stickney Zoning Ordinance, the Village Board of Trustees hereby initiate the Proposed Amendment to Section 8.01 and the Proposed Amendment to Section 8.02 and refer such to the Zoning Board of Appeals for a public hearing and a report and recommendation back to the Village Board. The Village Attorney and Building Official are hereby directed to provide the appropriate notice for a public hearing.
