DEPARTMENT REPORTS: Police Chief John Sladetz said today they implemented through our phone service, Call One, an automated call service for the police department and fire department. If anyone calls one of the non-emergency phone lines for the police or fire departments, you will get a menu. First of all, a recording will tell you to call 911 if it is an emergency. The menu will direct you a number of different departments. It is expected to take the strain off of the dispatchers. In addition, Chief Sladetz said that they expect the new squad cars to come in after May 1. The repairs continue on the existing squad cars. It is almost street sweeping time. Everyone needs to remember the signs and the days. They will be putting notices on the cars before they do any ticketing. This will be a reminder because everyone is still thinking snow which still could happen.

Fire Chief Larry Meyer updated us on the repair of the ladder truck which was hit on 39th and Central. It has been in the shop for a week-and-a-half and will next be sent out for an alignment. The new ambulance was supposed to be here by mid-March. It is in Columbus, Ohio. When it is finished, they will drive it to Rock Falls, Illinois where the graphics will be put on and install certain things. Hopefully we will have it by the end of the month.

RE: Morton College's Use of Rench Field for Home Softball Games for the Spring 2015 Season Dear Mr. Kreger,

Thank you for speaking with me on Wednesday, March 18, 2015 regarding the use of Rench Field by Illinois Community College District No. 527, Morton College, for Morton College's home softball games to be held in April during its Spring 2015 Season.

I understand that the Village of Stickney is the manager and authorized user of certain parkland, which include softball fields, and which is known as Rench Field, located at 42nd Avenue and Ridgeland Avenue in Stickney, Illinois. As you are aware, Morton College does not own suitable softball fields for use in collegiate athletics.

Please countersign below to acknowledge the Village of Stickney's agreement to the following:

- a. Morton College shall use Rench Field, free of charge, to play its home softball games per the Morton College Softball Team 2014-2015 Season Schedule attached hereto as Exhibit 1.
- b. Consistent with Morton College's use of Rench Field outlined in paragraph "a" above, the Village of Stickney permits Morton College, its officials, staff, employees, student athletes, and invitees to use for ingress and egress to Rench Field, the sidewalks, entrances, and passages to Rench Field, and permits Morton College, its officials, staff, employees, student athletes, and invitees to use the bathrooms at Rench Field, all free of charge.

- c. Consistent with Morton College's use of Rench Field outlined in paragraph "a" above, the Village of Stickney permits Morton College to use the water, lights, scoreboard and sound system at Rench Field (to the extent the same exist) free of charge.
- d. Consistent with Morton College's use of Rench Field outlined in paragraph "a" above, Morton College shall be responsible for providing bases and officials for its games.
- e. Morton College will use Rench Field in commercially reasonable manner and pursuant to Rench Field's rules, on the dates and at the times identified as Morton College Softball home games on Exhibit 1; Morton College will maintain total responsibility for its entire staff and student players.
- f. Morton College shall be responsible for maintaining and/or improving Rench Field to a suitable condition for collegiate softball games.
- g. Nothing herein shall be deemed or construed to evidence or create an employment, joint venture, partnership or other agency relationship between the Village of Stickney and Morton College.
- h. The Village of Stickney and Morton Colleges shall maintain in force for the entire duration of the Spring 2015 Morton College Softball Season (as identified in Exhibit 1 hereto), comprehensive general liability and property liability insurance, insuring against any and all claims, liability, demands and losses of judgment arising out of or occurring in connection with any act or omission of their agents, employees and/or students. This policy shall provide coverage against the aforementioned risks in the amount of not less than one million and no/100 U.S. dollars (\$1,000,000.00) per occurrence and one million and no/100 U.S. dollars aggregate. Such policies shall name each Party and their respective agents, officials, executives, employees, contractors, attorneys and students as Additional Insureds and provide that it is primary to and not contributing with, any policy carried by each Morton College and/or the Village of Stickney covering the same loss.
- i. Both Morton College and the Village of Stickney shall provide the other with certificates of insurance acceptable thereto and evidencing the existence of the coverage described above.
- j. Morton College agrees to abide by the terms of the Village of Stickney's Hold Harmless Agreement dated April 2, 2015 attached hereto.
- k. The Village of Stickney agrees to hold harmless and indemnify Morton College, its past, present, elected officials, trustees, directors, agents, officers, representatives, attorneys, employees, contractors, successors or predecessors against any losses, damages, judgements, claims, expenses, costs and liabilities imposed upon, incurred by or asserted against the Village of Stickney, including reasonable attorneys' fees and expenses, arising out of the acts or omissions of the Village of Stickney, its officers, agents or employees, or in any way related to the terms of this letter agreement.
