From the Desk of the Village Clerk, AUDREY MCADAMS



In January 2024, Governor JB Pritzker announced that the U.S. Census Bureau has approved the state's request to have nearly 47,000 Illinoisans included in future population estimates. The review found that 733 Group Quarters were missed or undercounted, along with a corresponding population of 40,512 people. The state also identified 123 dormitory settings where the population was undercounted for an additional 5,888 people. Although the nearly 47,000 identified people will not be added to Illinois official 2020 census numbers, the adjustment is crucial for the state's annual population estimates.

Eleven small cities in Illinois and Iowa are the only municipalities so far to have signed agreements with the U.S. Census Bureau for a second count of their residents in 2024 and 2025. They feel that they are leaving state funding for roads and other items on the table by not adding the extra growth to their population totals. Warrenville has added almost 1,000 new residents from several new housing developments. Urbana feels that the 2020 census missed 7,000 University of Illinois students. The local municipalities have to foot the bill for their special censuses. The cost could range from \$370,000 to almost \$500,000.

Stickney requested a Special Census on March 8, 1992. The 1990 Census found that Stickney's population was 5,678. Stickney paid \$23,000 to conduct the recount. On March 18, 1993 George M. Ryan, Secretary of State, informed the Village of Stickney that their new Census Population was 5,849.

The clerk is responsible for coordinating the Census every ten years. This responsibility expands over the course of two years. This is the biggest marketing project the Village undertakes. The clerk oversees the address charts that the Census uses to chart where the people are. Maps have to be evaluated. Contacts must be made with the group facilities. Promotions are organized with the schools. Any new construction has to be reported monthly. Any demolition has to be reported. Promotions have to be made with the residents to actually answer their Census applications. This diligence finds that Stickney's 2020 population is currently 7,110.

I want to give you a little information about your government here in Stickney. There are 2 main forms of Municipal government in our area. One being a Village manager form of government. The other is called a Strong Mayoral form of government. Both consisting of a Mayor or Village President and a board of Trustees. With a Village manager, that person oversees the

day-to-day operations. With the Mayoral form of government, the Mayor or President runs and oversees the day-to-day operations with the help of the board of Trustees. Here in Stickney, we have a strong Mayoral form of government. The Mayor's position is full-time, with a full-time clerk and 6 part time Trustees. The Mayor has the power to appoint the department heads. Police chief, Fire chief and Public Works director with the approval of the Board. The Village holds 2 board meetings per month. They are held on the 1st and 3rd Tuesdays at 7p.m. in the Village Hall. There is an agenda for each board meeting usually consisting of voting to pay bills, approving a community event, approving any new ordinances that may have been initiated by anyone on the board. The board meetings are for the Mayor and Trustees to discuss anything that is going on in our community. Reports are given by the Mayor, Clerk and Trustees to say if there is anything to make the board aware of. Reports are also given by department heads, the reports make the board aware of anything that may have happened since the last board meeting, or anything coming up in the future. There is also a segment of the meetings where a resident can make a statement or voice a concern to the Board. It is not a question-and-answer session, but a way to make the board aware of a concern. This is just a glimpse of how your government here in Stickney is structured. I hope it gives you a little insight. Meantime, join us for a board meeting sometime, you may find it interesting. Anytime you have a question or concern, please call the Village. The Mayor and the Board are here to serve you.

Spring will soon be upon us after another relatively mild winter. Although at the time of this printing we could still get cold spells and snow.

I would like to take this opportunity to hopefully prepare all of Stickney's residents for upcoming severe weather episodes. As we all know, the weather in the US has been getting more unpredictable and dangerous, with severe drought in the Western US, then getting so much rain and snow, to having too much water, to a lake forming in Death Valley, the driest place on earth, to flooding in the Midwest and East Coast. Severe weather seems to be normal now. Look at the severe weather we already had on February 27th,

2024, with heavy rain, and hail and will probably happen again as we get closer to spring and summer.

Be Prepared. If your basement tends to flood in heavy storms, try to make a plan to protect your expensive items such as electronics and furniture and pick it up off the floor. By doing this it could save a lot of heartache and expense if lost caused by flooding. Also, during heavy flooding storms, do not use any kind of water inside the house. Do not wash dishes or clothes, do not flush toilet unless necessary, shower or bathe until the flood chance is cancelled. Remember the sewer lines can only send water as much and as fast as they can hold. By not adding to the capacity, will help to get the storm water away faster. Visit "Understanding your sewer" on the Village website. www.villageofstickney.com. You can also help to prevent flooding by making sure any storm sewers by your home are clear of any debris that would cause water to back up. The Village checked all the storm sewers last year after the flooding and all were working as they were supposed to. There was such a large amount of water that the sewers had nowhere to go, but back up into people's homes. Again, this is not the Village's fault that this happens. Please try and make yourselves a plan for when the rain will come.

Remember Spring and Summer will bring events in the Village put on by the Parks & Recs Committee and the Village, such as Music in the Park, Family Day, Halloween Hayrides, Easter egg hunt, etc. Try to get out and enjoy these events with your kids and grandkids. Summer will also mean the kids will be out of school and outside playing. Please watch your speed in the Village (20mph) and **STOP** at all stop signs, and do not text and drive to keep everyone in the Village safe.

An allotment of new trees are purchased, donated and planted at no cost to the winners of this lottery.

- Only one tree per lottery recipient. Your tree will be the decision of the tree board committee to insure a diversified parkway tree population.
- Recipients of the lottery will be notified in early September and trees will be planted mid-October.

Tree options this year will be: Bur Oak, Crimson Sunset Maple, Armstrong Maple and Tri Color Beech.

All businesses in the Village of Stickney have Stickney business licenses.

The other important thing I would like to tell you about is our Stickney Township North Clinic located at 6721 W 40th Street. They offer many services. From the Desk of Police Chief, JAMES SASSETTI

If you are like us, we are happy to say goodbye to winter and hello to spring and summer. We are looking forward to seeing and interacting with residents as the weather becomes nicer. However, as the weather improves, more children play outside and take to the parks and community so use caution when driving and always be aware of your surroundings.

We want to remind you to report suspicious activity. Suspicious activity is any observed behavior that includes but is not limited to unusual items or situations. For example, a vehicle which is parked in an odd location, a

window/door is open that is usually closed, other out-of-the-ordinary situations or someone pays unusual attention to vehicles or buildings beyond casual interest. This includes extended loitering without explanation, unusual, repeated, and/or prolonged observation of a specific area or location. Some of these activities could be innocent, however, it's up to a police officer to determine whether the behavior warrants further investigation. Remember, it's important to be vigilant and aware of your surroundings in any environment but ensure that you report accurate information. Err on the side of caution and call the police if you observe any suspicious activity.

The Stickney Police Department recently launched the Frontline Public Safety Solutions overnight parking and vacation watch portal. Residents can now go to www.villageofstickney.com and click on the Frontline icon and register their vehicle for overnight parking permission. OVERNIGHT PARKING is restricted to residents only from 2am through 6am on all Village streets. Parking permission is limited to 3 consecutive days and 10 total days per month. If you need more nights than this, please call the police department at 708-788-2131 to see if additional overnight parking can be authorized. Pursuant to Section 14-151 of the Stickney Municipal Code it shall be unlawful to park commercial or recreational vehicles on any street or alley Monday-Friday between the hours of 11:59p.m. and 7:00a.m. and all day on Saturdays and Sundays. Also, residents can now sign up for a vacation watch on their residence when going out of town. Take advantage of this free service that offers peace of mind when out of town.

Remember to stay up to date on critical and informative police and Village alerts by signing up for Code Red. An icon to do so can be found on the Village of Stickney's website homepage at: www.villageofstickney.com.

In conclusion, SAVE THE DATE, we will be holding an open house at the police department on Saturday, August 3rd, 2024. We hope you can come tour our facility and see for yourself the behind-the-scenes operations of your police department. Please keep your eye out for the open house flyer. From the Desk of Fire Chief, JEFFREY BOYAJIAN

Greetings! Thank goodness it's spring! I am pleased to say that the Stickney Fire Department did not have any major fires throughout the Village this past winter. That is a testament to the residents and business owners within the Village who have taken the proper steps to reduce the threat of fire here in Stickney as well as a testament to the effort the Stickney Fire Department puts forth in its Fire Inspection and Fire Education programs.


Over the last year the fire department has received some new equipment as well as some firehouse upgrades which were made available through a grant

received by the Illinois Department of Commerce and Economic Opportunity (DCEO). We replaced one of the HVAC systems, remodeled the kitchen, purchased new rescue equipment, 19 new sets of structural firefighting gear as well as some needed fire suppression upgrades.

The Fire Prevention Bureau has started doing annual inspections of all the commercial and industrial properties within the Village, which will continue throughout the spring, summer, and fall seasons. They are also out doing pre-plans of these properties, which means the process of gathering and recording information of the property and certain hazards that may exist on the property that could be critical for firefighters making life-saving decisions at an incident. Property and lives can be saved when we have access to this critical information about the building, property, and the hazards we may encounter.

As we transition from winter to spring, we need to consider the threat of severe weather in our area. We can never over prepare ourselves for heavy rains, flash flooding, and tornadoes. Flashlights with extra batteries, fresh water, and a plan for everyone in your family is critical.

As we transition to the summer months the chances of heat related illness increase. See the chart below for signs to be aware of and the actions you should take if you start feeling any of these symptoms.









Notes from the Village Ordinance Control Officer **ARTURO TERRAZAS**

I want to bring to your attention the following issues that I see as I patrol around town.

Yard waste

The only time leaves should be put on the curb is during the leaf pick up program that takes place in the fall. If you are cleaning up dead leaves from the winter, do not put them on the curb, please put them in a yard waste container or bag to be picked up once yard waste pick up begins in April.

Make sure you clean up grass clippings. Do not blow them in the street or leave them all over the sidewalks.

When you're discarding branches or small trees, they must be cut into 3-foot lengths and bundled with string or twine. Each bundle should not exceed 2 feet in diameter or 10lbs in weight.

Accumulation of junk, debris, or litter on private or public property is not allowed. If you're storing wood, please keep it off the ground a minimum of 26" to prevent rodent problems.

CONSTRUCTION PERMITS AND REMOVAL OF CONSTRUCTION DEBRIS:

If you are planning on remodeling the interior or exterior of your home or business make sure you apply for proper permits. Construction material or waste should be disposed of properly and should NOT be put out for Public Works to take. It is the responsibility of the contractor or homeowner to have any construction materials removed. Any construction materials that are put out for Public Works or Waste Management to pick up will result in a ticket and fine. Any properties under construction of any kind are



responsible for maintaining area completely clean of garbage and debris at all times. Failure to do so will be issued a ticket and daily fines along with an adjudication court date.

Tires

I have seen tires put out for garbage pick-up. Waste Management and our Public Works will not pick up tires. Tires must be disposed of at your own expense. Do not store tires anywhere outside on your property.

White goods and bulk items special pick up

Special pickups will be done on Fridays. Items such as stove, refrigerator, dish washer, dryer, washing machine and electronics such as TV's, computers require a special pick up. If you have any of these items that you need to dispose of you can call the village hall at 708-749-4400 to be put on the list.

Waste Management will pick up only one piece of furniture on your regular garbage pick up day. If the furniture is too big, it should be broken down.

Please do not put anything out until the evening before it is scheduled to be picked up.

No parking on soft surfaces is allowed, in your yard, on the grass or dirt on public or private property.

ALL ORDINANCE VIOLATIONS ARE SUBJECT TO A CITATION AND FINE UP TO \$500.

Street Cleaning

Street Cleaning will resume the first Monday & Tuesday of April and will run thru December and will continue throughout the year weather permitting. Parking restrictions will be in effect during this time on Mondays and Tuesdays from 8:00 a.m. – 5:00p.m. and are as follows:

No parking Monday: North and West side No parking Tuesday: South and East side

The alleys will be swept twice a month May - December.

Maintaining your Sewer Line

You should make sure your sewer line is cleaned out at least every two years especially if you have a large home and family which will create a large amount of sewage waste.

How to Prevent Main Drain Clogs

- 1. Be on the Lookout for Warning Signs
- 2. Get Your Main Drain Checked Out
- 3. Make Use of a Mesh Lint Traps.
- 4. Let Bacteria Work for you
- 5. Avoid Flushing Solids down the Sinks
- 6. Flush Your Drains Occasionally
- 7. Don't Pour Grease down the Drain

How to Tell If Your Sewer Line is Clogged

- 1. Gurgling sounds coming from the toilet
- 2. Multiple slow-running drains in your home (low water pressure)
- 3. Water coming out of your shower when using the washing machine
- 4. Foul odors coming from your drains
- 5. Sewage coming back up through drains


Vehicle stickers will go on sale starting Monday, May 1st – June 28th, 2024.
